Dear Friends and Colleagues,

First, EARTO environment faced key changes with the European Union's political scene transformed by the European elections in May: new Presidents for the European Commission, European Parliament and European Council were elected. We also welcomed new Members of the European Parliament and new Commissioners, including Carlos Félix Moedas, new Commissioner for Research, Science & Innovation. In parallel, EARTO top management changed with my arrival in May as EARTO new

President joined by Frank Treppe (Fraunhofer-Gesellschaft) as new EARTO Vice-President in September. Accordingly, EARTO communication efforts increased largely last autumn in order to present the Association and its members to the new officials at the EU Institutions.

In the meantime, the EARTO Work Plan 2014 was successfully implemented by our Secretariat after key priorities and objectives were set up by the Board end 2013: our Working Groups were launched with success and have produced good contents this year. **Many thanks to all our Working Groups' experts and our active Steering Committee for their commitment this year!**

By promoting the 8 position papers delivered by our Working Groups, we worked hard all along the year reaffirming the strategic positioning of RTOs in working with an array of stakeholders in bridging the gap between basic research and market application.

In addition to organising a successful Annual Conference in Vienna with the great support of our Austrian members in May, we launched our new policy event in Brussels in October which presented

our Recommendations for Future EU Innovation Policy to some 200 high-level representatives from EU Institutions and key organisations.

2014 was also the first year of Horizon2020 implementation. Strongly supporting the Programme, EARTO members have been committed to delivering impactful projects working hand in hand with their partners and the European Commission. Thanks to our Working Group Horizon2020, we published our first feedback on the Programme's first calls in September. Our Working Group Financial Experts is also working towards the right implementation of Horizon2020, focusing on the Large Research Infrastructures (LRI) Scheme specially designed for RTOs.

In 2014 we started to follow closely the discussions on the EU 2015 Budget and President Juncker's €315 billion Investment Plan which are today threatening Horizon2020. Surely, we will continue to follow these dossiers throughout 2015.

To conclude, EARTO as the network where RTOs come together, exchange views and best practices, agree to convey common positions defending their interests and raising their visibility, has been very successful in 2014. We have closed an excellent 2014 and are now looking forward to 2015!

RTOs Positioning in Relevant

EARTO RAISING RTOS' PROFILE IN BRUSSELS:

- Published 2 key documents in 2014: EARTO Recommendations on Future EU Innovation Policy (accompanied by a specific Policy Event to discuss the paper) and EARTO Recommendations on the TRL Scale as a R&I Policy Tool.
- Continued communication campaign towards new officials from EC & EP to present EARTO following May elections.
- Raised the profile of RTOs and highlighted RTOs success stories: Impact Delivered showcasing high impact innovations, press release on Catapult Centres success in the UK (Hauser report), press release on high RTO participation in new EIT KICs Health and Raw Materials.
- Contributed to the on-going debate on R&I framework conditions in Europe linked with the publication of the EC Communication on R&I as Sources of Growth.
- Continued its collaboration with EC JRC and CEN-CENELEC on the topic of standardisation & innovation with the organisation of a joint event on Hydrogen and Natural Gas in October.
- Continued partnership with European Commission on the European Research Area (ERA): EARTO is member of the ERA Stakeholder Platform set up in 2012 and its working groups together with CESAER, EUA, LERU, Nordforsk and Science Europe. EARTO co-organised two sessions on ERA at the Innovation Convention 2014
- Established new dialogue or strengthened existing partnerships with key stakeholders associations: EIRMA and EUA (Responsible Partnering Initiative event in December), Business Europe and ERRIN (on synergies European Structural & Investment Funds (ESIF)/ H2020 and RIS3 dossiers, joint paper EAR-TO-ERRIN) and IGLO (joint paper on 1st Feedback H2020 Calls).

EARTO DEFENDING RTOS INTERESTS IN EU POLICIES:

- Followed the revision of the European new state-aid rules with 3 responses to EC consultations (RD&I framework, GBER, IPCEI) thanks to our WG Legal Experts.
- EARTO Board engaged in dialogue with ERAC on ERA Roadmap 2015, which outlines new Members States activities on R&I related topics.
- Positioned RTOs on synergies ESIF/H2020 and RIS3 dossiers: EARTO-ERRIN paper, strengthened collaboration with EC & JRC, EARTO invited to become member of EC Expert Group on Structured Dialogue on ESIF.
- Followed carefully the discussions around the EU budget 2015 and the cash flow problems of the EC: press release protesting against bugdet cuts published in October.
- Looked at minimising the impact of the new "Juncker Plan" on Horizon2020: Open Letter to Mr Juncker sent in December.

To promote and defend the interests of RTOs in Europe by reinforcing their profile and position as key players in the minds of EU decision-makers and by seeking to ensure that European RD&I programmes are best attuned to their interests; to provide added-value services to members to help them to improve their operational practices and business performance; to provide members with information and advice to help them make the best use of European RD&I programmes funding opportunities.

EARTO SHAPING EU R&I PROGRAMMES:

- Commented Horizon2020's implementation by publishing a feedback paper on the first calls of the programme in partnership with IGLO (network of Brussels-based non-profit R&D Liaison Offices).
- Kept regular dialogue with Horizon2020's implementing bodies (EC & agencies), supported by the EARTO WG Horizon2020.
- Closely followed Horizon2020's financial & legal frameworks: participation in the elaboration of the updated DESCA Model Consortium Agreement for Horizon2020, publication of EARTO guidelines on LRI scheme.
- Engaged in active collaboration with the relevant EC services for the implementation of the Large Research Infrastructures (LRI) scheme under Horizon2020, specifically designed for RTOs.
- Developed a new dialogue with the European Courts of Auditors: input on review of the EIT KICs and discussion around principles of good audits.
- Provided various specific inputs to the EC on Horizon2020 Instruments:
- Eligibility criteria for the new Fast Track to Innovation instrument.
- EC Synchronised Calls Initiative, FETs and the new SME Instrument.
- Inputs provided to EUREKA: e.g. on EUREKA New Strategic Roadmap.
- Responded to EC Consultation on Science 2.0 and Europe 2020.


